

2008 Ashton Pool Membership Application

Option 1-Apply to be a Permanent Member!

Bond + Annual Dues = Membership

Bond: Permanent members must pay a \$500.00 membership bond
*If you like, you may pay the bond portion of \$500.00 over a two year period: \$300.00 this year and the remaining \$200 with next year's dues payment. If you choose to do this, you would invest a total of \$730.00 this year **plus any special assessments**. Bond reimbursement: See Pool By-Laws available on the web site www.AshtonPool.com.*

Dues: Annual dues are \$430.00 PLUS, this year a \$20 Special Assessment for Playground Upgrades! It'll be great!

Both bond and dues must be sent with membership application below.

Option 2 - Apply for a Summer Only Membership. \$560

This is a one-time opportunity to make sure you love the pool as much as we know you will before moving to a permanent membership. Limited openings. (This fee does not apply to future years of membership.)

Option 3 – Apply for an Associate Membership \$190

Only available to nannies, au pairs, babysitters of regular members in good standing. Associate members are required to pay an annual fee established by the Board of Directors, but are not required to pay a bond or special assessments. Only one associate membership is available to each regular member per season. Associate members must be age sixteen (16) or older to be eligible, and shall be entitled to all Club privileges, except voting privileges.
